Title: "Impact of technology enabled knowledge translation: Validity of a new assessment method"** - An operating grant of \$217,500 for a 2 Yrs 6 months project in funded in the March 2007 CIHR open competition assessed by the Knowledge Translation and Exchange Peer Review Committee. the impact of information they retrieve. This research will test a method to examine the cognitive and behavioural impact of retrieved clinical information. If this information impact assessment method is valid, it will contribute to research to evaluate retrieved clinical information with implications for CME and assessing the quality of databases.

**2. Title: "What are the predictors of quality primary-care medical services? A comparative study of different organizational models in Québec"** - An award of \$169,802 each year for 3 years assessed by the Health Services Evaluation and Interventions Research-B Peer Review Committee. See: [http://www.cihr.ca/e/documents/200703mop\\_e.htm](http://www.cihr.ca/e/documents/200703mop_e.htm) . The objective of this study, which is both observational and analytical, is to compare variations in quality of care and in the management of patients with chronic illnesses, in different types of primary-care organizations (n=60). This study aims to identify internal and external (ENLEVER STRUCTURAL) and organizational factors that support high-quality clinical practices. The analytical framework addresses three dimensions: clinical care, practice organization, and patient experience. Three types of clinical settings will be studied in the regions of Central Montreal , the Mauricie, and Quebec-Centre: family medicine groups, CLSCs, and (enlever private et adjouter: fee for service group practices. In a context of relative scarcity of professional resources, this study will provide new data on the effectiveness of various organizational models for primary-care services by linking them with measurements of clinical outcomes. The methodology will also make it possible to develop a set of tools for measuring primary-care service performance that take into account different dimensions, i.e., achievement of clinical outcomes objectives, user satisfaction, and the evaluation of care processes.

As an independent private foundation, the Burroughs Wellcome Fund seeks to accomplish two primary goals: to help scientist early in their careers to develop as independent investigators, and to advance fields in the basic biomedical sciences that are undervalued or in need of particular encouragement. The Career Awards for Medical Scientist program provides to each recipient \$700,000 over five years to bridge advanced post-doctoral/fellowship training and the early years of faculty services. Candidates eligible to this funding opportunity must hold a clinical degree such as a M.D., D.D.S., D.V.M., Pharm. D., and be a clinical fellow, resident, instructor or a postdoctoral researcher and have at least two years of research experience at the time of application.
