Provincial/territorial results available: Results of the 2007 National Physician Survey, organized by province/territory, were released on March 18, 2008.



You will be able to find a Media Release and short summary of the provincial/territorial results, as well as data tables by FP/GP, other specialists, sex and age group for each province/territory, at www.nationalphysiciansurvey.ca.

Results for medical students and residents will be publicly released later in the spring. After all releases are complete, individual requests for data analyses specific to your areas of interest will be accepted, and a sample of the record-level data will subsequently be made available to researchers for study purposes. The 2007 NPS results are being highlighted in Canadian Family Physician with monthly **Fast Facts**. The February issue focuses on patients' access to cancer care services. Efforts to reduce wait times in priority areas, including cancer care services, have been made, but there's still much work to be done. 19% of FPs responding to the 2007 National Physician Survey rated access to cancer care services as only fair or poor.
