### Dear Members

Building the discipline of family medicine research is a multi-faceted activity that requires input from a wide community of contributors. In recent months, we have seen an increased focus on the value of family medicine research and the positive outcomes that have resulted from the work of many in our family medicine community.

With this month's issue of Kaleidoscope, we congratulate Dr. Jeannie Haggerty, Associate Member of the College and a member of the Section of Researchers' Executive, on her appointment to the first McGill Chair in Family and Community Medicine Research. Internationally known and cited, Dr. Haggerty is known to many Section Members for her work in family medicine research, which has focused on measuring accessibility to care, as well as quality and continuity of care. She is an Associate Professor of Family Medicine at McGill University. The research chair is one of the several structures which will institutionalize the growing research profile of the Department.

The appointment will be based at St. Mary's Hospital Centre in Montreal, a university-affiliated hospital recognized as a leader in Quebec for its community-oriented care. Dr. Haggerty says that her goal will be to "contribute to the creation of structures to capture patients' and care-givers' concerns, and to partner with clinicians in doing research on questions that occur in their day-to-day contact with patients."

In addition to her appointment at McGill University, Dr. Haggerty also assumed the Presidency of the North American Primary Care Research Group (NAPCRG) at the organization's annual meeting in Montreal in November. She will work to increase membership and participation among Canadian family physicians in NAPCRG, and foster international, as well as Canada - U.S. collaboration among family medicine researchers. Her focus will be on ensuring the use of research to influence health care policy and effect positive reform in health care delivery.

We look forward to reading more about Dr. Haggerty's work in the months to come!

## Research News

### \* Member Research Highlight

Dr. Bo Miedema, PhD, member of the Section of Researchers' Executive and Director of Research at the Dalhousie Family Medicine Teaching Unit in Fredericton, NB, will be the principal investigator on a new study entitled "A new model of cancer follow-up care for young adult cancer survivors in Atlantic Canada".

Previous studies led by Dr. Miedema ([Abstract: From "invincibility" to "normalcy": coping strategies of young adults during the cancer journey; Young adults' experiences with cancer](#)) show that the majority of young adults aged 20 - 44 survive their cancer diagnosis, but their lives are filled with physical, social and psychological challenges due to their ages at diagnosis and subsequent late effects caused by cancer treatment. The Canadian Strategy for Cancer Control (CSCC) has identified the need for a national model of cancer follow-up/supportive/rehabilitative care, particularly for young adult cancer survivors, so that they can live with minimal levels of illness and other problems. The CSCC argues that evidence-based follow-up (supportive or rehabilitative) care guidelines should incorporate psychological and sociological needs.

The team plans to interview between 50 and 60 young adults diagnosed with cancer between the ages of 18 and 34 in Atlantic Canada to learn about their physical and psycho-social needs in follow-up care. They hope to identify gaps in the current model of cancer follow-up care for young adults in Atlantic Canada, and to use the knowledge gained to modify the current model of cancer follow-up care to include psycho-social issues.

The project represents a first step towards an evidence-based follow-up care model in Atlantic Canada. Read the [article](#) highlighting the upcoming study, which appeared recently on the CBC.

**\* Post-doctoral Fellowship in Primary Care Oncology, 2010-2011 University of Manitoba, Canada**

Deadline: March 31, 2010

With funding from the Canadian Institute of Health Research (CIHR), the **Departments of Community Health Science and Family Medicine**, University of Manitoba, along with CancerCare Manitoba, will offer a two-year **Post-Doctoral Fellowship in Primary Care Oncology** to commence **July 1, 2010**.

The mandate of this Primary Care Oncology-New Emerging Team (NET) is to combine the university's expertise with the experience of those who work in the field of primary care and oncology to create innovative, new ways of improving the care of patients and families, and the development of research capacity. Current thematic areas of investigation with the NET include; i) examining the extent to which administrative data sets can accurately capture colorectal screening practices; ii) exploring the role of family members in enhancing adherence with colorectal cancer screening; iii) developing interventions that support family physicians in promoting colorectal cancer screening; and iv) examining the extent to which the transition of patients from specialist to primary care follows established screening guidelines. Research approaches include both qualitative and quantitative methodologies.

The postdoctoral fellow will be expected to work collaboratively on the group grant as well as undertake an independent research project dealing with a topic in Primary Care Oncology. The supervisor of this postdoctoral fellowship will be determined depending on the chosen research topic. The research team includes epidemiologists, nurses, physicians and health services researchers. Applicants should be not more than three years beyond their completed PhD; candidates with a defense scheduled by May 2010 are welcome to apply. This competition is also open to MDs with appropriate training and experience.

### **Canadian Institutes of Health Research - Canadian Medical Association Journal Top Achievements in Health Research - 2009**

**Full applications must be courier stamped by April 1, 2010**

The aim of this competition is to acknowledge Canadian health research achievements that have had a significant impact on health, health care, and health research by improving our understanding of health and human diseases, tackling health challenges, and improving our health system.

The Canadian Institutes of Health Research (CIHR) and the Canadian Medical Association Journal (CMAJ) **invite individuals or teams of health researchers, health professionals and others** to submit significant achievements they may have made in any area of health research. Achievements will be selected from the following four categories: (i) biomedical; (ii) clinical; (iii) health services; and (iv) population and public health.

The [Top Health Research Achievements](#) as selected by an international review committee will be considered for publication in the CMAJ. The individuals and teams responsible for leading this work may also be highlighted on the CIHR web site and other communications materials.

The CMAJ and CIHR recognize that the full impact of an achievement takes time. In many cases, full impact or appreciation may not be realized for several years. **As such, this competition will acknowledge research that has achieved impact within five years of the current competition year. This award is NOT targeted to lifetime achievement in research or capacity building in research.**
