Dear Members:

The CFPC Section of Researchers congratulates Section members and their colleagues in other primary health care research settings who have recently received funding through the CIHR's Community-Based Primary Health Care Team Grant opportunity. The competition focused on two broad thematic areas: chronic disease prevention and management in community-based primary health care, and reducing inequities in access to community-based primary health care and health care outcomes in vulnerable populations.

These are exciting times for primary health care researchers. Approximately \$30 million will flow from CIHR to our research sector over the next five years, giving us the opportunity to directly influence the transformation of health care in Canada, and to demonstrate the value of family medicine and primary care research in the development of patient-centred care for Canadians in the years to come.

These awards clearly demonstrate the CIHR's recognition of the significant contribution primary care research can make to the ongoing development of health care in Canada. Each of the successful research teams has demonstrated very high standards in the formulation of their research questions and the development of outstanding interdisciplinary, interjurisdictional and multi-method research proposals that will benefit all Canadians. We are now positioned to demonstrate our ability to produce evidence that will help ensure that the Canadian primary health care system is able to meet the challenges of the coming years.

I have personally witnessed noteworthy growth and maturity in primary health care research as we learned to share across teams

for the benefit of all. In addition, our research “elders” have shown remarkable leadership in making this process a collaborative success. I extend our thanks to them.

While members of the funded teams are busy starting to think about the enormous task of implementing their ambitious programs of research, others, along with the dynamic, skilled individuals on their teams, are contemplating how to move forward with their excellent research ideas and plans, despite being without the financial support they sought. It would indeed be a huge loss for all of these new relationships to be for nought, or for all of these great ideas to go to waste. We at the SOR recognize this and will be working to explore creative ways of helping all the applicants move forward.

Each speaker will be given 3 minutes to present their idea. Audience members then have the opportunity to challenge the speakers, critique the ideas, and cast their vote to choose the most potent dangerous idea, which will be published in Canadian Family Physician.
